Notes:

- The financial results have been reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on February 14, 2024.
- The Company operates in one primary segment only, i.e. Ophthalmics Lenses and therefore Ind AS 108 - Operating Segment is not applicable.
- Board of Directors of the Company in its meeting held on August 12, 2022, had changed the accounting policy from April 1, 2022, by treating glass moulds as part of the inventory which were earlier treated as Property, Plant and Equipment (PPE) and depreciated over its estimated useful life. Due to the change, 'Depreciation and amortisation expense' for the quarter and nine months ended December 31, 2022 was lower by Rs.32.46 lakhs and Rs. 96.10 lakhs and 'Cost of materials consumed' was higher by Rs. 8.69 lakhs and Rs. 24.85 lakhs respectively.
- However, Board of Directors of the Company had reviewed the change in the aforementioned accounting policy as at the year ended March 31, 2023 and concluded that the glass moulds were to be reinstated as PPE in line with the policy followed in the year ended March 31, 2022.
